This does not waive rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. I agree to indemnify and hold harmless GSMS, its officials and members for any loss, liability, damage, or cost which may incur due to my presence at a GSMS event, whether I am competing, officiating, or observing a GSMS event.
3. I assume the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risks can cause.

I reserve to GSMS and its members and officials, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee-shirts, and other such novelty concession items, written articles about me, photos and drawing of my likeness or of my racecar. This does not prohibit me from producing promotional products, nor does this allow GSMS to take any proceeds from material produced by me, unless marketed by GSMS.
5. By signing below, I agree to follow all the rules and regulations and responsibilities as printed in the GSMSRC rules. I hereby release the officials of from damages resulting from their decisions and/or interpretations of rules.
